

Terms and Conditions

GENERAL TERMS AND CONDITIONS OF USE

The www.sporita.com website (the "Website") is maintained by Sporita a private limited liability company incorporated under Israeli law and registered in Israel whose registered office is at Rothschild 20 st, Tel Aviv, 6688123 ("SPORITA", "We", "Us" or "Our").'

These are the terms and conditions (the "Conditions"), which apply to the use of the Website by you (the "Users"). By accessing any section (including sub-domains) of the Website or any other websites that we own and/or have registered on the Website, you agree to be bound by the Conditions and our Privacy Policy and are deemed to have accepted and understood all the Conditions.

The Website is provided for the benefit of Users who are 18 years old or older. If you are not over the age of 18 or do not agree to be bound by the Conditions, you may not use the Website and we will have the right to restrict or prevent your access to the Website.

Please read the Conditions carefully and if you do not accept the Conditions, do not use the Website.

Reference to "you", "your" or the "user"/"User" is a reference to any person using the Website or the services of SPORITA and/or any registered user of SPORITA.

SCOPE OF SERVICES

SPORITA provides access to premium content generated by our service through the Website and email newsletter. Access is based on subscription model. Premium content consists of predictions of future results of sport events and advice (tips) on how and where to place a bet in order to win. Our unique algorithm generates content based on statistics and news analysis.

SPORITA does not take money by gambling. SPORITA does not accept any form of gambling, betting or wagering.

SPORITA is just advisory service. Any information published by SPORITA is for informational and entertainment purposes only.

SPORITA is not responsible for any win, loss or damage for the user, either

direct or indirect, as a result of using this information for gambling or betting.

By signing up for a periodical newsletter you are consenting and allowing us to send you emails containing free analysis and specials, industry news and more. We will provide this information to you free and assure you that your email or private information will not be sold, traded or given away to anybody. To be added to our newsletter list, simply mark the appropriate box to add your email to the list.

PAYMENT REQUIREMENT

The User is to be billed in advance by SPORITA for the subscription offered. Before the subscription is available for use, the User must accept the Conditions as presented. User, by purchasing our service for the desired period of time in one of the three subscription models as described below, gets access to the member's private area, secured by login name and password.

Payment methods

Users pay instantly on the Website. Access to premium content becomes valid as soon as the payment is approved. Prices for using SPORITA are subject to change upon 14 days notice from SPORITA. Such notice may be provided at any time by posting the changes to the Website or the administration menu of your SPORITA account via an announcement.

Users can sign-up by filling in the form on the Website. Paypal is the only form of payment currently available on our website (We will be adding more payment methods soon). By the time the transaction is approved - the user has access to the premium content. The subscription is renewed automatically at the end of each subscription period. In order to cancel the automatic subscription please log in to your Paypal account and cancel your subscription according to their instructions.

In the event if, at the day of prolongation of your subscription, we are not able to charge you due to insufficient balance of funds available at your account or credit card, we will try to charge you again during the following 3 days and if we are still not able to charge you, prolongation of your subscription will be cancelled (with no obligation for you to pay for such

prolongation).

The user has 14 calendar days to claim a full refund from the date he purchased a subscription. This applies only to first time subscription.

Payment models

There are three payment models available:

a) 30 day access (each 30 days -is considered one month, automatically prolonged for subsequent 30 day periods if not terminated by the User

b) 90 day- access (automatically prolonged for subsequent 90 day periods if not terminated by the User

c) 180 day- access (automatically prolonged for subsequent 90 day periods if not terminated by the User

USER OBLIGATIONS

Users must read, agree with and accept all of the Conditions and the Privacy Policy before they may become a member of SPORITA.

Users will not:

1. use the Website (or any part of it) for any illegal purpose and agree to use it in accordance with all relevant laws;
2. upload or transmit through the Website (i) any computer viruses, macro viruses, trojan horses, worms or anything else designed to interfere with, interrupt or disrupt the normal operating procedures of a computer or (ii) any material which is defamatory, offensive, or of an obscene or menacing character, or that may cause annoyance, inconvenience or anxiety;
3. use the Website in a manner which (i) may cause the Website to be interrupted, damaged, rendered less efficient or such that the effectiveness or functionality of the Website is in any way impaired or (ii) violates or infringes the rights of any person, firm or company

(including, but not limited to, rights of intellectual property, rights of confidentiality or rights of privacy);

4. create or publish a hypertext link to any part of the Website or attempt any unauthorized access to any part or component of the Website.
5. reproduce, duplicate, copy, sell, resell or exploit any portion of the Website, without the express written permission of SPORITA.

Users must provide their full legal name, a valid email address, and any other information needed in order to complete the signup process and are responsible for keeping their password secure. SPORITA cannot and will not be liable for any loss or damage from your failure to maintain the security of your account and password.

The User is not allowed to share or reproduce purchased information with anyone.

OUR ENTITLEMENTS

We reserve the right to:

1. modify or withdraw, temporarily or permanently, the Website (or any part of it) with or without notice to you and confirm that we shall not be liable to you or any third party for any modification to or withdrawal of the Website;
2. change these Conditions from time to time. Your continued use of the Website (or any part of it) following such change shall be deemed to be your acceptance of such change. All changes will be published on the Website. It is your responsibility to check regularly to determine whether the Conditions have been changed. If you do not agree to any change to the Conditions then you must immediately stop using the Website;
3. monitor any activity and content associated with the Website. We may investigate any reported violation of these Conditions or complaints relating to the Website and take any action that we deem appropriate (which may include, but is not limited to, issuing warnings, suspending, terminating or attaching conditions to your access and/or removing any materials from the Website).

We will use our reasonable endeavors to maintain the Website. You will not be eligible for any compensation because you cannot use any part of the

ACCOUNT

In order to use the services offered at the Website the user must have a valid account.

SPORITA allows all its users to choose their own username and password combination. The username you choose must not be obscene, threatening, menacing, racist, offensive, derogatory, defamatory or in violation of any intellectual property or proprietary rights of any third party and if we consider, in our sole and absolute discretion, that the username selected by you is inappropriate we reserve the right to reject and prevent your use of such username at any time with or without notice to you.

After you have created an account with us, you will subsequently be required to enter your username and password in order to access your account and make use of the Website. Users must keep the information about their username and password secret and confidential as you are responsible for any activities taking place on your account.

All information supplied when registering with the Website must be accurate and complete in all respects.

As part of the registration process, we may supply your information details to authorized credit reference agencies to confirm your identity and payment card details. You agree that we may process such information in connection with your registration.

The account is subject to Israeli law. All transactions concerning this account are processed as per Israeli law.

Upon clicking on the "Join Sporita" button on our registration page the user will be presented with our registration form which includes the mandatory insertion of personal details and account details including a valid email address, username and password. The user is also requested to confirm that he is over 18 years of age and that he has read and accepted our Conditions and the Privacy Policy.

Users have the right to correct and/or erase wrong or inappropriate data at any time.

Users have the right to close their account without giving any reason. In

order to do so, the user has to inform SPORITA via e-mail. As soon as SPORITA has received such an e-mail the user's account will be closed accordingly.

YOUR PERSONAL DATA

We respect your personal data and shall deal with it in accordance with our Privacy Policy and applicable Israel Data Protection legislation.
